



POET Biorefining

Located in Leipsic, POET Biorefining is a state-of-theart ethanol production facility offering an environmentally friendly fuel and livestock feed. When the COVID pandemic hit, POET saw the critical need for hand sanitizer and modified its operations to meet the national demand. The company attributed its productive workforce, access to three rail lines and proximity to customer base as key factors in choosing the Putnam County site to produce the product. POET has donated hand sanitizer to local schools, police and fire departments, and the area community center.

High Volume Production

Over the last several years, the Regional Growth Partnership has successfully worked with its economic development partners in building a more diverse industry base. Yet we still recognize and value our traditional manufacturing sector as a critical driver of our economy. In 2020, the RGP and its partners closed 43 projects under the advanced manufacturing umbrella. These projects produced more than 2,000 new jobs, which represented a 60% increase from the previous year.

There is a need for testing pilot technologies in urban and rural real-world settings.

The Regional Growth Partnership has initiated efforts to identify companies in the autonomous testing market as well as to position and sell the Toledo region as a viable location for such testing and deployment.

As part of this campaign, the RGP contracted with Automotive News, hosting a webinar for the publication's thousands of subscribers about finding the right place and right partners to test and deploy autonomous technologies.


An Industry Game-Changer

recent partnership between CSX and BNSF allowing goods to come from the west coast directly into North Baltimore has been described as a 'game changer' for the industry. Bypassing Chicago saves enormous time and money, mitigating risk within the supply chain.

To capitalize on that, NorthPoint Development built a logistics park adjacent to the CSX Intermodal Terminal, which now offers a cost-effective and convenient solution for shippers to connect between truck and warehouse in a matter of minutes.

With this new incredible asset, the Regional Growth Partnership will market, promote and sell the opportunities nationwide for businesses to take advantage.







United Parcel Service

With facilities already near Toledo and Columbus, UPS needed additional sorting and delivery capacity and sought the most suitable location in Northwest Ohio. The company, with more than 500,000 employees worldwide, ultimately chose North Baltimore, becoming the first tenant in Logistics Park Ohio, adjacent to the CSX Intermodal Terminal.

UPS, the world's largest package delivery company, cited the infrastructure and proximity to the interstate as key factors in its site location decision, providing better efficiency and time-in-transit. The new facility will be fully automated.

Filling the Pipeline

ore and more businesses are taking advantage of Northwest Ohio's connection to the natural gas market by tapping into the region's vast pipeline network. Understanding the abundance of natural gas and the pipeline infrastructure to transport that asset, the Regional Growth Partnership has implemented several marketing campaigns highlighting opportunities within our region.

Last year, the RGP worked with <u>Site Selection</u> magazine promoting the competitive advantages for businesses in Northwest Ohio that utilize natural gas, noting that because supply is so great, industrial users can access the resource at a very low competitive price.




Supply Chain Stability

Throughout 2020, businesses across the U.S. battled through disruptions caused by the global pandemic and strived to become fully operational once again. Broken supply chains became exposed, and social unrest in major cities added even more unpredictability.

Understanding Northwest Ohio's offerings under those circumstances, the RGP initiated a campaign to businesses positioning this region as a solution to supply chain disruptions. The campaign focused on three major themes:

- 1. Secure Supply Chain
- 2. Regional Stability
- 3. JobsOhio & State Proactive Response to Pandemic

Messaging emphasized that business was still coming to Northwest Ohio, and companies looking to improve their situations needed to consider this region right away.





Supply Chain Stability

As part of its campaign promoting Northwest Ohio as a solution to supply chain disruptions, the RGP <u>created a new web page</u> recognizing those attributes which focus on a secure, reliable and efficient supply chain, the ability to mitigate risk in Northwest Ohio, and a business-responsive government.

Added points to that communication included:

- Greater Balance & Certainty in a Low-Risk Business Setting
- Added Attention to Business Needs During Disruption



International Awareness

Despite a tumultuous year worldwide, the Regional Growth Partnership's international efforts held steady in 2020. With analysts predicting a 30%-40% drop in foreign direct investment globally, the RGP saw no decline in the number of new jobs created.

Several major attraction projects of internationally owned companies contributed more than 300 new jobs to Northwest Ohio. Those new businesses to the region included Logoplaste (Portugal), Nova Tube and Steel (Canada), HP Pelzer (Germany) and Marelli (Italy).

Overall in 2020, the region brought in \$400 million of new foreign capital investment and nearly 900 new jobs.

Export Success

The RGP continued in 2020 the Export Success program in conjunction with the Toledo Regional Chamber of Commerce. The purpose is to help companies develop an export plan or to improve efficiencies of their export process.

The now virtual 10-month program covers topics such as overseas markets, international sales process, logistics, finance/banking and marketing.

Students of the program are expected to present their export plan at the end of the program.

Significant for this year, because of its enormous success, Export Success 2021 will now run as a statewide program supported by Ohio Development Services Agency's export office.

Site & Building Management

The Regional Growth Partnership takes a lead role in managing and promoting the 17-county region's real estate inventory. Last year alone, the RGP performed more than 50 searches resulting in 15 company visits to more than 30 sites and buildings in Northwest Ohio.

In 2020, JobsOhio introduced the Ohio Site Inventory Program (OSIP), established to create inventory within the state that is not being organically developed but has proven demand and known-economic benefit. To date, JobsOhio has funded speculative buildings at Land-Air Industrial Park across from Toledo Express Airport and Harmon Business Park in Defiance. The continued need for modern buildings and shovel ready sites that meet the needs of today's companies will continue to serve as a major focus in 2021.

Talent Acquisition

To better support companies locating and expanding in Northwest Ohio with their hiring needs, the Regional Growth Partnership works through the JobsOhio Talent Acquisition Services (TAS) program to identify a company's talent challenges and build sustainable talent strategies. TAS provides direct support to companies over an 18-to-24 month period of time to fill the company talent pipeline. The services, including marketing, prescreening and training, are customized for each company and match the project's specific goals.

In 2020, Virtual Career Fairs were created and implemented in Northwest Ohio as a direct response to companies' hiring needs impacted by COVID. A number of events are planned throughout the region in 2021.
