OTHER HIGHLIGHTS

- Annual RGP FAM Tour attracted 10 national site consultants for a three-day period to learn about the regional assets and hear industry executives discuss doing business in Northwest Ohio.
- RGP hosted economic development sales training for LEDOs and elected officials with nationally recognized consultant Carol Johnson.
- Implemented an aggressive digital advertising program allowing the RGP to greatly expand its reach to key target audiences in a very cost-effective manner.
- International attraction efforts generated more than 500 new jobs and \$700 million investment from two dozen companies coming from Canada, Europe, Asia and Brazil.

SUCCESSFUL INITIATIVES

Ohio Site Inventory Program

Continued utilizing the successful Ohio Site Inventory Program to spur spec building development across Northwest Ohio. OSIP was established to create inventory within the state not being organically developed by the market but has proven demand. The JobsOhio program provides grants and loans, seeking to leverage investment of developers and minimize risk. Since the program's inception, 13 projects have received assistance with 4-5 more planned.

Inclusion Grant

Facilitated 10 projects where companies received financial support through the JobsOhio Inclusion Grant program. The JOIG provides grants for projects in distressed communities and businesses owned by underrepresented populations such as minorities, women, veterans and those with disabilities. Support is intended for small and medium-sized businesses with annual revenues under \$25 million.
