#### SUCCESSFUL INITIATIVES

#### JobsOhio Small Business Grant

Established to serve distressed communities and businesses owned by underrepresented populations such as minorities, women, veterans and those with disabilities, the Small Business Grant provided funding to 36 companies across Northwest Ohio in 2024. These businesses created 124 new jobs and brought in grant funding of \$1.1 million. The grant is intended for small and medium-sized businesses with annual revenues under \$25 million.

#### Northwest Ohio Innovation Consortium (NOIC)

The State awarded NW Ohio more than \$31 million to accelerate innovation and job growth within the glass and solar sectors. The award to NOIC, with the RGP a proud member, is to create the Glass Innovation Hub. Funding comes through the Ohio Innovation Hubs Program, with the Toledo region being the first statewide recipient of the grant which is also supported with more than \$10 million in local investment. Private sector businesses will conduct research and work to develop new technologies to solve challenges within the solar and glass industries.



#### **OTHER HIGHLIGHTS**

- An aggressive and dynamic marketing program generated nearly 200 leads, having resulted from a well-rounded, robust strategy to reach key target audiences in the most efficient and cost-effective manner.
- Northwest Ohio made a dramatic statement with its showing in the 2024 Site Selection Governor's Cup awards. Seven communities within the 17-county Northwest Ohio footprint were ranked among the best nationally based on number of business development projects.
- The RGP was presented a coveted President's "E" Award for excellence in export service, recognizing achievements in making significant contributions to an increase in U.S. exports.
- The annual RGP FAM Tour attracted nine national site consultants for a three-day period to learn about the regional assets and hear industry executives discuss doing business in Northwest Ohio.
